The T-Lid board reviewed the Wenck Report that was finalized this month.

After much research and data collection there were three recommendations made:

A Sheet Pile Weir at the mouth of the bayou channel.

Wetland B Impoundment.

Cover Crop Implementation.

It was decided that Scott would invite Dan Cibulka, SWCD, to a future meeting to share his insight and expertise regarding the Briggs Lake Chain Wenck Report (hopefully in March or April).

#### **New Business:**

- Elk Lake TLID Kenzie and Scott have agreed to meet with Elk Lake residents when they are ready to move forward with this.
- Curly Leaf Pondweed 2021 Mike F

Mike F presented information regarding the spraying of the lakes next year for Curly Leaf Pondweed. The Freshwater Scientific survey recommends 94.7 acres to be sprayed but the DNR will only allow us to spray 66.5 acres.

Mike F presented a proposal on how to make this happen. Because this was the committee's first look at this proposal it was decided to review it again next month and make some decisions. Harry E and John S will specifically focus on the west side of Briggs Lake since that is one of the largest cuts in spraying that Mike F is proposing.
