HEALTHY LAKES REPORT

Notes from the Healthy Lakes February Meeting

Cameron Graber and Ruth Thom were introduced as the new co-chairs. The TLID update from Scott Ruiter included information on lake surveys planned for 2022, including early Curly Leaf Pondweed and early milfoil in Rush and Big Elk. A point intercept survey on Big Elk was discussed and the HL committee members recommended that the BLCA board pay for a baseline survey this year. The TLID has filed grant applications with the state to offset the cost of AIS treatment, as well as applied for a grant through the Sherburne SWCD to cover Purple Loosestrife pulling. Big Elk is working on similar grants. The BLCA will be using a new company this year for AIS treatment. The costs are higher up front, but the company has a better track record in reducing weeds, so the expectation is that within a few years we will be treating much smaller areas and therefore saving money in the long run (as well as better controlling weeds). Discussion was also held on how to educate residents of the importance of removing the dead weed bogs that result after spraying happens. If the dead weeds are allowed to decompose in the lake, they add to the nutrient levels. Steve Demueles reported that the county is also making plans to purchase a piece of property where residents could dispose of organic matter (lake weeds, as well as leaves, small branches, grass clippings, etc). Chuck Heinemann reported that there are 6 active Gentle Footprints projects on


Briggs (four are cost-sharing with the BLCA and SWCD). Any new applications for projects will be for 2023.

HL goals for 2022 were drafted and will be reviewed and finalized at the March meeting. In other business, the committee discussed ways to better educate new residents, lake visitors, and BLCA members regarding best practices for healthy lake use and shoreline regulations. Discussion was also had regarding law enforcement's availability and their difficulty in enforcing current lake regulations. Local township boards are currently working to rewrite ordinances so that they are enforceable.
