TLID: DNR grant proposals for 2024 have been completed. Gary Anderson is working on a grant for funds to combat Eurasian Water Milfoil on Big Elk Lake.

COLA: Will be working on a new 5yr. AIS plan, starry stonewart is present in several MN lakes, DNR will be enforcing AIS treatment's to be completed by May 15, 2024, 2024 sponsorship materials are being generated, there is discussion going on of possible restrictions for wake boats, and of a possible increase in the license surcharge for watercraft. State funds may be made available for the prevention of Aquatic Invasive Species (AIS).

Water Testing: Walt Munsterman attended a virtual meeting on November 17 about the water testing being done by Sherburne County lake associations. There was discussion of them using the same testing center for the water samples taken. No decision was made. Wright County COLA offers a group discount to its lake associations for voluntary participation in the SWCD.

Healthy Lakes: Ruth Thom and Bre Bauerly are working on a Lake Steward program. They will present details at the June General Membership meeting of the BLCA in 2024, the DNR grant received will allow for a carp study to be done in the summer of 2024 in all 4 of the Briggs Lake Chain lakes.

Big Elk Park: Tom Nordin shared information about the new park. A representative of the Bureau of Indian Affairs recently came to visit the area. It will be called Two Inlets Regional Park, or Bde Hehaka. A \$2.5M grant was approved and work has begun. Anyone interested in the project is welcome to attend the meeting held at 12:30 P.M. on the third Thursday of each month at the Sherburne County Government Center in Elk River.
