BLCA Lake Conservation Program – History

* Gentle Footprint Conservation and Native Plant Program *

Program and Projects to date:

The BLCA has promoted lake improvement and supported conservation efforts for a long time. We have used our own resources in addition to obtaining grant funding from other agencies to help property owners pay for lakeshore restoration and runoff control projects. This work began in

2000 with a total of 60+ projects completed on the four lakes so far! These have included shoreland restorations, run-off control, and rain gardens. Funding sources have included the Minnesota DNR, Sherburne Soil and Water Conservation District, and Elk River Watershed Association in addition to projects funded solely by the BLCA. We also developed a Plant Bank program to provide replacement plants for property owners who have lost native plants through erosion or winter kill.

All projects have used native (deep-rooted) plants to slow the flow of rainwater and allow it to absorb into the soil to reduce pollutants and nutrients flowing into our waters.

2023-24 Program

Last year in addition to the BLCA-funded Gentle Footprint Program, we were able to partner with the Sherburne Soil and Water Conservation District (SWCD) in a combined SWCD Cost-Share/BLCA Gentle Footprint program. The SWCD has said they plan to continue the Cost-Share program in the future.

The "Class of 2023-24" consisted of twelve projected projects on Briggs, Elk, Julia and Rush Lakes – some of which will have joint funding and some are BLCA funded only. Detailed planning is occurring now with planting to follow in early summer of 2024. See future issues of The Lake Report and the BLCA website for updates on these projects.





Know the rules

- Legal: Blowing away floating surface debris and algae, if lake bottom is not disturbed. No permit is needed.
- · Not legal: Using a hydraulic jet in any way that disturbs the lake bottom or uproots aquatic plants. Illegal use of hydraulic jets may result in a citation, restoration order or both from a state conservation officer.





What can I do about the lake weeds?

To keep nutrients, which can feed weed and algae growth, from entering the lake

- Minimize or eliminate the use of fertilizer on your lawn.
- Maintain a vegetative buffer along your shore, it captures nutrients before entering the lake and prevents erosion.
- Clean up after your pet (in your yard or on the ice). Pet waste is a major nutrient source.
- Take care when mowing or blowing leaves that debris does not get in the lake.

Using an herbicide without a DNR permit is a misdemeanor and may result in a citation.

What can I do without a permit?

- You may cut or pull submerged vegetation, such as Elodea, without a DNR permit under certain conditions:
 - o The area to be cleared must be no larger than 2500 sq. ft.
 - The cleared area must not extend more than 50 ft along the shoreline, or ½ the length of your shoreline, whichever is less.
 - The 2,500 square foot area may also include a boat channel up to 15 feet wide, and as long as necessary to reach open water (the boat channel is in addition to the 2,500square feet allowed). The cutting or pulling may be done by hand or with hand-operated or powered equipment that does not significantly alter the course, current, or cross-section of the lake bottom. Such control cannot be done with draglines,bulldozers, hydraulic jets, suction dredges, automated aquatic plant control devices, or other powered earth-moving equipment.
 - In floating-leaf vegetation, a lake shore property owner may maintain a channel 15 foot wide extending to open water by mechanical means without a permit. Any other destruction of floating-leaf vegetation requires a permit.

After you have cut or pulled aquatic plants, you must dispose of them on land to prevent them from drifting onto your neighbor's property or washing back into the lake. If you plan to dispose of aquatic vegetation someplace other than on your property, you will need to download the aquatic plant transport authorization form from the MN DNR website. See www.dnr.state.mn.us



FACTS ABOUT BUI

BUI ENFORCEMENT

Alcohol can impair a boater's judgment, balance, vision and reaction time. It can increase fatigue and susceptibility to the effects of coldwater immersion.

Sun, wind, noise, vibration and motion — "stressors" common to the boating environment — intensify the effects of alcohol, drugs, and some medications.

Alcohol use is the leading contributing factor in recreational boating deaths.

Alcohol use is dangerous for passengers, too. Intoxication can cause slips, falls over board and other dangerous accidents. Operating a recreational vessel with a Blood Alcohol Content of .08 or higher is against state and federal laws.

The U.S. Coast Guard standard for determining if a boat operator is intoxicated is when the effect of an intoxicant (alcohol or drugs) on the person's manner, disposition, speech, muscular movement, general appearance or behavior is apparent by observation and/or through the administration of a chemical test.

If you boat under the influence your voyage may be terminated, the boat may be impounded and the operator may be arrested.

Penalties vary by state but can include fines, jail and loss of boating or even driving privileges.
